



HAULOUT & HARDSTAND CONDITIONS
OWNERS MUST PROVIDE AT LEAST TWO CAPABLE
HELPERS TO ASSIST WHEN HAULING OR LAUNCHING

The following rules and regulations are compiled for the protection of your yacht and gear. Please abide by them as they ensure personal, as well as property safety.

1. Owners, Captains, or their representatives must complete a Hauling Launching form and invoice prior to hauling. The full cost for must be prepaid.
2. No one will be allowed to remain on board any vessel being hauled or moved.
3. No prop stands may be moved at anytime. Please ask for assistance from Yard personnel.
4. No outside vehicles shall be permitted to operate within the work yard without Management's approval.
5. All work is to be performed by officially recognized crew or yard personnel only.
6. Outside contract work is strictly prohibited without prior management's approval. Approved outside contract labor is subject to a 10 percent commission payable to Ocean World Marina. Unauthorized Freelance labor contract is not allowed at any time. Violation of this rule shall be cause for immediate settlement of all current charges and immediate launching regardless of the status of work in progress.
7. Do not help yourself to materials or stores please ask for assistance from a yard employee.
8. Power tools will not be rented or loaned to anyone desiring to do their own work at any time whatsoever.
9. Anyone found tampering with yard equipment or materials will be subject to covering replacement costs, fines, or prosecution by Marina Management.
10. The yard takes no responsibility for accidents, injury, or death to any persons in or working within the yard at any time. All persons wishing to enter the boat yard for any reason do so at their own risk.
11. The raising of sails or removal of standing rigging is strictly prohibited while yachts are on hard standing. No one shall go aloft ever while on yard property.
12. Open fires are prohibited at all times.
13. Long Term Storage fee requires a minimum of 3 months prepaid.
14. The position of the vessel in the yard is up to Management.
15. Spray painting is permitted only with prior approval from yard.
16. Management requests that all vessels keep their area clean. Waste oil must be put into approved receptacles. Non crushable waste must be put into the collection slip.
17. All outstanding bills must be paid with proper proof of receipts prior to launching any vessel.
18. Please lock your boats and dinghies when unattended. The marina is not responsible for any lost items.

CAPTAIN'S RESPONSIBILITY:

- a) My boat is in fully insured and the club has a copy of the policy.
- b) My cradle, if applicable, is in good condition.
- c) Marks are on the starboard side for the cradle support or the lifting points.
- d) My lines and fenders are on the starboard side.
- e) My pump out is made.
- f) My boat is on the gas dock ready at the date of the haul-out. Your presence or a delegated person on board is recommended. If not I will be charge \$50.00 for the Marina to do so.

Waiver of Liability

The applicant acknowledges, and it is a condition without which application shall not be accepted, that use of the Maritima Del Atlantico, SRL harbor, premises, service or privileges is at all times solely at the applicant's risk and neither the Yard nor those whom it is responsible in law shall be liable for any loss or damages to the applicant's yacht or other property for any cause whatsoever. The applicant does, by this application, hold the club harmless and indemnified from any loss or damage of whatever nature and however caused during launch, mooring, haul-out, storage and /or other related services of the applicant's yacht, cradle, trailer or other property by the Yard, hereby expressly agreeing that such yacht shall be launched, moored, hauled-out and stored at the applicant's sole risk and peril. The applicant solemnly declares that the yacht described above belongs to the applicant. I hereby confirm that my yacht, cradle, trailer and / or other property is fully insured in respect to public and general liabilities.
